HOST EVENT T-SHIRT DESIGN CONTEST AGREEMENT FOR PLAYFWD EVENTS

This Agreement is entered into between PLAYFWD and Seeds For Dreams 501(c)3 and (student name) _____, a ____ citizen ("Assignor"), (parent/guardian) _____. In consideration of the promises and obligations contained in this agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor/Student agrees as follows:

You must incorporate the following elements into your design

1. PLAYFWD LOGO in it's original design and colors
2. Must be visually and politically appropriate
3. The date of the event, location or school name, where applicable.
4. Express cultural identity or design from the Country/location of the event.
5. Designs may include line art and text but no photographs.
6. Your design is for the front of the shirt and may encompass an area up to 10" x 10". Only at the bottom of the logo.
7. Design may use a maximum of three colors. Colors should be full and not spotted.
8. Please include your name - designer name or initials, on the left bottom corner of the design
9. The design must be your own original, unpublished work and must not include any third-party logos or copyrighted material. By entering the competition, you agree that your submission is your own work.

Submitting an Entry

10. Paper entries for appropriate age groups will be accepted.
11. Digital entries accepted as well for higher age groups. High-resolution images in .eps format are preferred. We will also accept VECTOR art entries in the following formats: .ai, .cdr, .pdf, .svg, .wmf. All fonts must be converted to curves. There should be no embedded bitmap images (jpg, tif, bmp).
12. Colors should be spot with no half-tones. Note: if white elements of your design do not show up when you convert to one of these formats, add a navy background for viewing purposes.
13. Please sign this document completely and email to info@playfwd.org with a subject line: "EVENT T-shirt Contest - Name of School or Host Event"
14. Submissions will be accepted 4 weeks prior to all events only.

The Fine Print

15. Maximum of one entry per person.
16. T-shirt will be produced for the HOST Event only.
17. All entries must include a signature signed by the artist/student and a parent/guardian signature below to be considered.
18. Submissions will be screened for appropriate content.
19. Only those students registered for the race will be able to vote for the final design.
20. Voting is set up as one vote per person. In regards to our voting system, if we find irregularities that appear to indicate someone is trying to manipulate the voting system in their favor they will

be immediately disqualified. This includes gaming the system through scripts, resetting IPs, going from computer to computer, etc.

21. The PLAYFWD reserves the right to make changes to the winning design before printing, including changes in image size or ink color or t-shirt color.
22. By submitting your design, you grants, delivers, and passes all design copyrights to PLAYFWD and Seeds For Dreams, including, but not limited to, our website, T-shirt and future marketing materials.
23. PLAYFWD staff reserves the right to final decision.
24. The winning design will be announced 3 weeks prior to the event.

Representations and Warranties

(a) Third Party Rights. Assignor hereby represents that he/she possesses the right, power, and authority to execute, perform, and deliver his/her obligations under this Agreement; and that the Work does not infringe the copyright, patent or trademark rights of any third party. Assignor further represents that the Work will not libel any third party, or otherwise violate or infringe any rights whatsoever of any third party, including, but not limited to, any rights to privacy.

(b) No Transfer, License or Disclosure. Assignor hereby represents that he/she has not transferred, sold, assigned or licensed any rights to the Work to any third party.

(c) Indemnification. Assignor shall indemnify and hold harmless PLAYFWD and SEEDS FOR DREAMS, its affiliates, licensees, and assigns, and their respective officers and employees, from and against any and all claims that may arise as the result of or in connection with a breach or alleged breach by Assignor of his representations, warranties, or obligations under this Agreement.
